PURPOSE

Imagine a gift that lasts not for a day, or a season, or a year... but forever.

Since 1993, donors have given gifts to the Endowment Fund. The principal is never spent; a portion of the investment income is available each year to enhance our church's facilities, missions, and ministries.

Annual stewardship supports the church's ministry here and now; a gift to the Endowment Fund helps secure the church's mission into the future.

A substantial Endowment Fund will assure the church's sustainability and excellence for decades. It is a gift for the future as we enjoy today what was given by those who came before.

How Do I Give?

ENDOWMENT FUND

There are a number of ways to participate:

- Bequests You may specify a dollar amount or a percentage of the assets in your will.
- Commemorative Gifts You may give a gift of cash (checks), appreciated securities, a life insurance policy, an annuity, or property to the Endowment Fund to commemorate an important event, honor a loved one, or as an expression of gratitude and thanksgiving.
- Planned Gifts These gifts provide income for you or a beneficiary during your lifetimes and benefit the church thereafter, or provide yearly income to the church during your lifetime, and, afterward, benefit your family or friends.

 - Charitable Remainder Trusts
 - Gifts of Property
